The Mustang Band Program is proud to serve more than 950 students. Mustang High School features four concert bands, two jazz ensembles, an auditioned jazz combo, three competitive winter guards, two performing percussion ensembles, an applied music class and the 220-member Nightrider Marching Band. Two ensembles under Mr. Edgmon's direction have been featured at the Oklahoma Music Educators Association Convention: Jazz Ensemble I (2012) and the Mustang High School Wind Ensemble (2015). Mr. Edgmon completed his degree in Instrumental Music Education at the University of Oklahoma in 2004, is a member of Oklahoma Music Educators Association, Jazz Educators Network, National Association for Music Education, Oklahoma Bandmaster's Association and Phi Beta Mu International Band Fraternity. He is also an active adjudicator and clinician, as well as a freelance visual designer for marching bands scattered across the Midwest. <u>Dr. Jason Hausback</u> is the Assistant Professor of Trombone at Missouri State University, where he also directs the Jazz Studies Ensemble II. Other performance credits include international engagements in Europe, South America, and Asia. In 2008, he was the winner of the Eastern Trombone Workshop National Solo Competition. Mr. Hausback has served on the staff of many prominent high school marching bands in Texas, including Marcus HS (2007-present), the four-time reigning Texas 5A State champions. He has also worked with the Capital Sound Drum and Bugle Corps (2004-2006), the Madison Scouts (2008, 2009) and Spirit of Atlanta (2012, 2013).

<u>Martin Dunlap</u> has worked in education for the past 38 years as a band director, high school assistant principal, consultant, adjudicator and university professor and administrator. He has taught all levels of high school band and orchestra in both small and large high school settings. He served nineteen years as director of the Blue Valley High School band program in Stilwell, KS.
