Chris Church

Chris Church, a graduate of Missouri State University, is a 41-year Veteran Band Director, having served 32 years as the Director of Bands and Fine Arts Department Chairman in Willard, Missouri, and then spent 6 years in the Springdale Har-Ber Band Program, Arkansas. He is currently on staff with the Pride Band Program at Missouri State University as the drill writer/instructor and teaches low brass methods. His marching bands and jazz bands have consistently placed at or near the top in all festivals attended and he has also worked as a drill designer for numerous bands



throughout the Midwest. His Wind Symphony earned State Level Honor I Ratings for 32 consecutive years. Chris taught all brass classes at both schools, primarily serving as the Euphonium, Trombone, and Tuba Specialist. He has over 20

years of experience working within Drum Corps International, spending 13 seasons with the World Champion Phantom Regiment Drum and Bugle Corps from Rockford, Illinois where he worked with 6 DCI Hall of Fame members. While with Phantom Regiment, Chris served on the Marching/Visual Staff, Visual Caption Head, and drill writer. He is currently serving as a Visual Judge for Drum Corps International (DCI), He has provided marching clinics and adjudicated marching bands, concert, and jazz ensembles in 27 states throughout the United States. Chris has also judged in 3 different Winter Indoor Circuits judging color guard, percussion, and winds. He is a graduate of the Marching Roundtable Judges Academy and also adjudicates concert bands, solo and ensembles, and jazz festivals. Chris is a certified solo/ensemble and concert band judge for Missouri and Arkansas. Chris also was awarded a Fulbright Scholarship, and taught in Tokyo and Kanazawa City, Japan.

Additionally, Brian is the director of the Southern California Percussion Ensemble Festival, held annually in Irvine, California. Brian is a member of the Percussive Arts Society, and proudly endorses Ludwig/Musser instruments, Promark sticks and mallets, Evans drumheads, Meinl Percussion and Zildjian Cymbals.
